

# Perry County Assessment Year 2023 Real Estate Assessments

## NOTICE TO TAXPAYERS OF PERRY COUNTY ASSESSMENT YEAR 2023 REAL ESTATE ASSESSMENTS

The following is a list of assessment changes in Perry County as well as a complete list of real estate parcels in Townships 5S Range 3W for the 2023 assessment year in Perry County. This publication is made in accordance with Section 12-10 of the Property Tax Code and serves as public notice to the taxpayers of the assessed values fixed upon their property by the Supervisor of Assessments. The assessment of property, other than farmland and coal, is required by law to be assessed at 33 1/3% of fair market value. You may check the accuracy of your non-farm property by dividing your assessment by the median. The resulting value should equal the estimated fair cash value of your non-farm property. If the resulting value is greater than the estimated fair cash value of your property, you may be over assessed. If the resulting value is less than the fair cash value of your property, you may be under assessed. Based on actual sales of real estate in Perry County, IL during the past three years (2020, 2021 & 2022), the Illinois Department of Revenue conducts sales ratio studies to determine the current, 3-year average (median) level of assessment for each township. From this information, equalization factors are developed to achieve uniformity in levels of assessment. An equalization factor of **1.0964** has been applied to all property in Perry County for the 2023 assessment year, except farm property and coal.

If you believe that the full fair market value of your property is incorrect or you believe it is not uniform with other comparable properties you may wish to contact your Supervisor of Assessments Office to review your assessment. If after reviewing details of your property with the Supervisor of Assessments Office, you still believe your assessment is incorrect, you may wish to file an appeal with the Perry County Board of Review. Appeal forms and a copy of the Board of Review rules may be obtained by contacting the Supervisor of Assessments Office at **618-357-2209** or visiting [www.perrycountyil.gov](http://www.perrycountyil.gov). Appeals must be filed on or before June 28, 2024, which is 30 days from the date of this publication. Your property tax bill is calculated as follows:

**Final Equalized Assessed Value – Exemptions = Taxable Assessment;**  
**Taxable Assessment x Current Tax Rate = Total Tax Bill.**

**Owner occupied properties may be eligible for various homestead exemptions as provided for in Section 15-165 through Section 15-175 and Section 15-180 of the Property Tax Code. **Farmland Assessments:** Pursuant to the 35 ILCS 200/10-115, the farmland assessment for the 2023 assessment year (payable 2024) will increase by 10% of the preceding year's median cropped soil productivity index as certified by the Illinois Department of Revenue with data provided by the Farmland Assessment Technical Advisory Board, resulting in a **\$42.61** per acre increase for each soil productivity index.
